The Privilege of the Floor:

Ron Jones Billings Hill Rd. Ron had complaints from three other residents in the town on Billings Hill Rd, the complaints were about the chickens and dogs that are going on residents properties. They are from 1488 Billings Hill Rd. The residents have complained to the owners and to the Dog Control officer at which nothing has been done. I have prepared a letter to the town board from the neighbors of Billings Hill Road. We have multiple concerns regarding the animals at large, owned by residents in 1487. Billings Hill Road. The first concern is the three dogs often left to run at large. We are all tired of cleaning up after their unwelcome visits. Second are the various poultry birds left to run free range about the town. The birds this year include chickens and turkeys. We are tired of chasing them off our lawns cleaning up after them and repairing the damage they cause. They are also causing delays by obstructing motorist daily commutes. We would like the town to enforce the dog laws, specifically section seven number one, which is unlawful for any dog to run at large. If not already law, we would like the town to adopt the law. Like the dog laws for residents to keep poultry birds and other animals confined to their property. No roosters allowed in The Hamlet would also be welcome. Respectfully submitted. Code enforcement Officer Aaron Camp went over to talk to the resident that is living there, and he said he does not own the dogs, Aaron stated that they cannot let the dogs, or the chickens run on other residents properties. He told them they must get them contained.

Aaron Camp stated that underneath section 302.9 code defacement of a property.

David Craine was present to present the new Insurance policy, He went over the policy with the Town Board. The Town Board made some changes and discussed the policy.

Deep Spring Rd- the 284-agreement is for Deep Springs Rd, which will go under CHIPS. All the gravel, crusher run, binder for the road will be coming from Norwich is shorter and cheaper.

There is a grant for the cutting edges for the snowplows, Jamie will be applying for this.

They will have the trucks calibrated for the sand spreading in October.



Jamie learned at the Highway School that CHIPS will go back to 5 years instead of the 10 years they do know. Highway Superintendent Jamie Goedel stated that the town can keep Deep Springs Rd open to one lane, and NYS will come in for an inspection every three months.

Agreement for the Expenditure of Highway Moneys

AGREEMENT between the Town Superintendent of the Town of Lelans A Madison County, New York, and the undersigned members of the Town Board.

Pursuant to the provisions of Section 284 of the Highway Law, we agree that moneys levied and collected in the Town for the repair and improvement of highways, and received from the State for State Aid for the repair and improvement of highways, shall be expended as follows:

- GENERAL REPAIRS. The sum of $\frac{9}{1.2}$ miles of town highways, including sluices, culverts and 1. bridges having a span of less than five feet and boardwalks or renewals thereof.
- PERMANENT IMPROVEMENTS. The following sums shall be set aside to be expended for the 2. permanent improvement of Town highways:
